Application and Rush Fees	
Application Fee for Jointly Provided activities (all applicants except U of A COM - Tucson)	\$350
<ul> <li>Rush Fee for activity applications received &lt;60 days prior to the activity's start date</li> </ul>	\$500
• Special Rush Fee for activity applications received <30 days prior to the activity's start date	\$1000

CME Providership Fees	
1.) Regularly Scheduled Series (RSS), i.e., Grand Rounds, Case Conferences, Tumor Boards, etc.	
Direct Provider RSS Fee (U of A COM - Tucson)	\$1250
Joint Provider RSS Fee (all other applicants)	\$1500
2.) Live Courses/Live Conferences/Live Workshops/Live Webinars	
Direct Provider CME Providership Fee: All credits of your activity	\$1250
<ul> <li>Joint Provider Base CME Providership Fee: 0.25-3.0 credits/hours</li> </ul>	\$1250
<ul> <li>Joint Provider Additional Credits Fee: for programs &gt;3.0 credits/hours per credit</li> </ul>	\$110

• Joint Provider Base CME Providership Fee: 0.25-3.0 credits per year	\$1250

<u>Note</u>: Enduring Materials are usually approved for 2-year periods. We invoice for the fees applicable to both years of CME providership at the time of approval.

## **Attendee Registration Fees**

Use of the U of A CloudCME system to register your attendees and collect payment for paid activities:

- Standard Paid Registration Configuration
  - 3% Credit Card Processing Fee (deducted by bank)
  - o CME Office Service Fee (deducted by the CME Office from your final payout)
    - 3% of the Gross Registration Fees, plus \$100 (processing refunds, reconciling final net revenue report, interfacing with U of A Financial Services to process payout, etc.)

Potential additional fees for use of the U of A CloudCME system to register your attendees for either paid or free activities:

- Advanced Registration Configuration
  - Starting at \$200, based on any of the following options:
    - Preconference workshops/tracks
    - Single day registrations for a multi-day event
    - Multiple tracks on single days of the conference
    - Promo codes (free attendance, "Early Bird" rates, etc.)
    - Customized registration form (e.g.: meal selection, swag options, free or for-fee conference materials, etc.)

# **Activity Configuration Fees**

For all activities that manage the CME documentation experience of their attendees within CloudCME (evaluations, certificate issuance, etc.):

- Standard Activity Configuration
  - No charge. Includes one, "default" activity evaluation.
- Advanced Activity Configuration
  - Starting at \$200 based on any of the following options:
    - Pre-activity survey
    - Pre/post test/assessment
    - Customized evaluations (adding "your questions" to the default evaluation questions)
    - Multiple evaluations (an evaluation for each day of your activity, for example)
    - Online content configuration

## **MOC Fees for Select ABMS Boards**

- Maintenance of Certification (MOC) Fee
  - 50% of the base CME Providership fee for all activity types.

We are only able to award MOC points for the ABMS Boards that are aligned with the ACCME PARS Reporting System. Currently, those Boards are:

- American Board of Anesthesiology (ABA)
- American Board of Internal Medicine (ABIM)
- American Board of Orthopaedic Surgery (ABOS)
- American Board of Otolaryngology–Head and Neck Surgery (ABOHNS)
- American Board of Pathology (ABPath)
- American Board of Pediatrics (ABP)
- American Board of Surgery (ABS)
- American Board of Thoracic Surgery (ABTS)

Depending on the given Board, additional requirements to award MOC points may apply, such as your need to create - and our need to configure - a formal assessment for a live course/conference or per session of an RSS activity.

**NOTE**: CME activities that involve general surgery topics are automatically approved for ABS CC credit (in addition to AMA/PRA Category  $1^{TM}$  CME credit). There is no additional fee for ABS CC credit.

## **Miscellaneous/Optional Fees**

- Multiple Event Fee: For live courses comprised of the same content and that is repeated >2 \$100/event times per 12 months at the same or different physical locations.
- Payments for any fees made via credit card will incur a 3% credit card processing fee.
- Processing fees for commercial support (grants) received from ineligible companies: Contact us for discussion. (Usually we do not apply for, or "route," commercial support grants for direct or joint providers.)

We invoice for fees following approval of CME Providership or upon delivery of other services. Joint providers who decide to cancel their approved activities remain liable for application fees. Please refer to our Refund Policy.
